# Minutes of the Board of Selectmen Meeting

Wednesday June 19, 2019

### First order of business: Bid Opening

Sealed bids for removal and construction of approximately 200ft of a 10ft wide concrete sidewalk on the west side of Main St. were opened by the board.

- 1. Pelow & Sons \$81,412.75
- 2. Pat Rawson \$80,476 (new curbing) \$75,047.50 (old curbing)

The board made no decision on awarding the bid, because there is not a full board. Also, would like Dale & Margaret to look over both bids.

### Second order of business: Minutes & New Business

The board reviews the minutes of 6-12-19 for approval. Selectman Leustek makes a motion to approve the minutes. Selectman Kilanski seconds the motion. The motion carries 4-0.

Selectman Leustek made a motion to approve the Church Steeple Project Acknowledgement document for the LCHIP Grant. Selectman Stephens seconds the motion. The motion carries 4-0.

Chief Tollett asked the board to post speed limit signs on Old Westport Rd & Howard St. Selectman Kilanski made a motion to approve the speed limit signs for both roads. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski made a motion to approve a timber tax for map 4 lot 72-2 in the amount of \$2,157.13. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski made a motion to sign the agreement with BRI Roofing for the gutters system for the Thayer Library. Selectman Leustek seconds the motion. The motion carries 4-0. Board agreed on white gutters.

Karey said that Steve Bracket has offered to repair the Town of Winchester sign on the front lawn. The board agreed to allow Steve to repair it. The board thanked Steve for the amazing job he did on the Welcome to Winchester sign. Karey informed the board that Steve made a Music in the Park sign that will be placed near the Kiwanis sign on Main St. and will be removed in August.

Selectman Kilanski made a motion to sign the agreement for the new website CivicPlus. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Marsh made a motion to approve the agreement for Jones Rd between the TOW & L. Lawrence Excavating. Selectman Kilanski seconds the motion. The motion carries 4-0.

Selectman Kilanski makes a motion to make an internal transfer for office supplies. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Marsh made a motion to approve a sewer invoice for Carlsen Systems in the amount of \$5,187.00. Selectman Kilanski seconds the motion. The motion carries 4-0
