### Minutes of the Board of Selectmen Meeting

#### First order of business: Minutes

The board reviews the minutes of 1-9-19 for approval. Selectman Heinonen makes a motion to approve the minutes. Selectman Leustek seconds the motion. The motion carries 5-0.

## Second order of business: New Business

The Board signed off on the original warrant which will be post with the MS-737 before town meeting.

Gary Jackson's Heating Service asked the board to enter into a contract to service all town building. The board review the proposal and are not in favor of a contract.

Selectman Heinonen made a motion to approve the sewer abatement for map 32 lot 13 in the amount of \$234.65. Selectman Marsh seconds the motion. The motion carries 5-0.

Selectman Heinonen made a motion to approve the tax abatement for map 1 lot 51 in the amount of \$1,246.85. Selectman Marsh seconds the motion. The motion carries 5-0.

Mike also asked if the Ambulance warrant article passes is the goal to renovate the Ashuelot Fire Station for the Ambulance to be housed there. The board said yes.

Selectman Stephens asked how much will it be to fix the fencing near the Thayer Library in Ashuelot. Dale stated he put cones on the piece that are broken and will look at it in the spring.
