Minutes of the Board of Selectmen Meeting

Wednesday September 12, 2018

Board members present: Jack Marsh, Herbert Stephens, Roberta Fraser and Gloria Leustek. Also, present Rick Meleski, Dale Gray and LT Tollett.

First order of business: Minutes

The Vice-Chairman opens the meeting at 7pm. The board reviews the minutes of 9-12-18 for approval. Selectman Marsh makes a motion to approve the minutes. Selectman Stephens seconds the motion. The motion carries 4-0

Second order of business: New Business

50/50 Raffle Permit was submitted by RED Committee for Dinner on the Bridge. Selectman Marsh makes a motion to approve the permit. Selectman Fraser seconds the motion. The motion carries 4-0

October 20th is the State auction at the White Barn in Concord. Selectman Marsh asked Dale if he would be going. Dale said he might go the day before to preview what was there.

Monday September 24th is the NH Fire & EMS Committee of Merit award night. Dick Lapoint will be recognized.

This year the committee has hire 2 people to be at the crosswalks by the United Church and the corner of Main St & Richmond Rd.

Jason Koerber asked Dale to clean the Ashuelot Bridge for the dinner September 29th. There will be signs in place the week before the dinner to let everyone know the bridge will be closed 9/29 from 2pm-10pm.

Lt Tollett let the board know that J&J finished putting the speed sign on its own trailer and it is on Parker St.

Mike Coope asked if residents can take the leaves that have been bagged in large paper bags to the landfill and place them in the burn pile. Karey will ask MDS.
