# First order of business: Budget Work Session

The Chairman opens the meeting at 6:00 pm.

Selectman Kilanski makes a motion to approve Town Clerk-\$108,681. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski makes a motion to approve Emergency Mgmt.-\$15,936. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski makes a motion to approve Land Use-\$79,603. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski makes a motion to approve Health-\$5,897. Selectman Leustek seconds the motion. The motion carries 4-0.

Chief Tollett and Principal Carey have been working on the Emergency Operation Plan. They would like to schedule a workshop with Town Admin, Highway, Emergency Management, ELMMCC staff and Police to come up with a Reunification Plan. The meeting will run about hour and half. The date and time will be announced soon.

2 quotes for the Conant Library Roof were submitted. 603 Roofing-\$24,540 and WCRC (Walker Roofing)-\$72,350. Tabled until there is a full board.

Selectman Kilanski made a motion to approve the 2019 Audit Agreement with Vachon & Clukay. Selectman Leustek seconds the motion. The motion carries 4-0

Senator Jay Kahn sent a letter to the board giving information on the State Budget that was recently passed. Winchester will receive \$228,583 in unrestricted revenue redistribution and \$1,701,814 in additional education funding for a total of \$1,930,397 in municipal aid for 2020-2021.

# The board reviews and approves the following financial documents:

Selectman Kilanski makes a motion to approve the Culvert repair capital reserve request to SVE in the amount of \$135.00. Selectman Leustek seconds the motion. The motion carries 4-0.

Selectman Kilanski makes a motion to approve the Fund Balance Policy. Selectman Leustek seconds the motion. The motion carries 4-0. Amy stated the last time it was done was 2012 and there has been no changes.

Amy gave the board the 2020 Health & Dental agreement letter to review and sign. It is not due until December 13th. The board will review for next week's meeting.
