We'll know better by the end of September after kids are back to school and some time goes by whether or not it is safe to go indoors in town hall. New roads signs have arrived and Jason will get these setup on the a-frame and put back out on Main Street.

Music in the Park – Series is now over.

Halloween Haunted Bridge – Jason spoke with Margaret and currently she doesn't seem to think that there will be an issue with planning this event, but we will need to hash out detailed safety protocols. Kiwanis will do their costume contest and food, etc in partnership with ELMM if ELMM decides to move forward with their annual Halloween events/activities. Jason hasn't spoken to Jessica yet, but will work on connecting with her. If they do it, will we draw people away? Should we choose a different weekend or the Friday beforehand? We don't want to compete; we want to enhance. If we do it, we will need the help of other individuals and local groups – we can involve high school kids, moco arts, theater groups, etc. We'll table any detailed planning for now until we get some info from Jessica about the ELMM's potential plans/thoughts.

Pole Banners – Jason has hardware and has stuff and is going to fix them! Jason spoke to Karey about the application to the utility about additional poles. She hasn't heard anything, so she reached out again. We'll continue to wait. What about businesses that have flags but are no longer in business? We keep those up until they break and then we'll replace them with another.

Main Street Beautification Grant – We'll explore starting this conversation at next meeting.

Town Concerns – Nothing to report.

New Business – Christmas wreaths: Jason put it on Karey's radar. She also thinks we'll be able to still do Santa in the Park with social distancing. Lola presented the idea of including a "letter to santa" component this year in lieu of photos with Santa, so that kids can drop off their letters and Santa comes to pick them up. We can get creative.

Next meeting will be socially distanced in person at the park on Main St. unless it rains.
