New Business:

Affordable Connectivity Program (ACP)

Jenn & Nichole researched – If you enter your address into the portal, it should populate – Jenn's did not. She called and was able to find it. Group reviewed and need to enter address slowly while it searches database.

- ACP was put together during COVID started with a \$50 benefit has now decreased to a \$30 discount per month for eligible households
- Ensures households can afford broadband
- Can also receive a one-time discount up to \$100 to purchase a laptop, desktop computer or tablet from participating providers if they contribute more than \$10 and less than \$50 towards purchase price
- Limited to one monthly service per household
- Eligible if household income at or below 200% of federal poverty guidelines
